## A reconsideration of whether or not to refer the closure of Wanstead Hospital to the Secretary of State for investigation by the Independent Reconfiguration Panel

There will be an Extraordinary Health Scrutiny Committee meeting in the Council Chamber at 7:15 pm on Wednesday 13 May. This is because [a quote from the meeting papers] *"It was the view of the Chair and the Spokespersons that this Extra-ordinary meeting be convened to consider if there is sufficient evidence to support further pursuit of the referral previously made to the Secretary of State for Health (SoS) and to delegate the Director of Adult Social Services, Health and Wellbeing to respond accordingly to the SoS in consultation with the Chair and Spokespersons."*

You can read the 64 page document by going to Redbridge i/All sections/The Council/Meetings Calendar/13 May. To point out the main pages: 1 = Agenda, 3-7= history of the consultation, 20-21= Redbridge's letter of referral to the SOS, 22 = SoS response **the key quote in this letter is:** *"It would be helpful if the Committee could provide further evidence, referring specifically to the provisions as laid out in the Regulations, in order for the request to be appropriately considered."* 23-27 detailed instructions on how to provide the necessary information, 43-50 a highly biased table putting the pros and cons of continuing with the referral.
